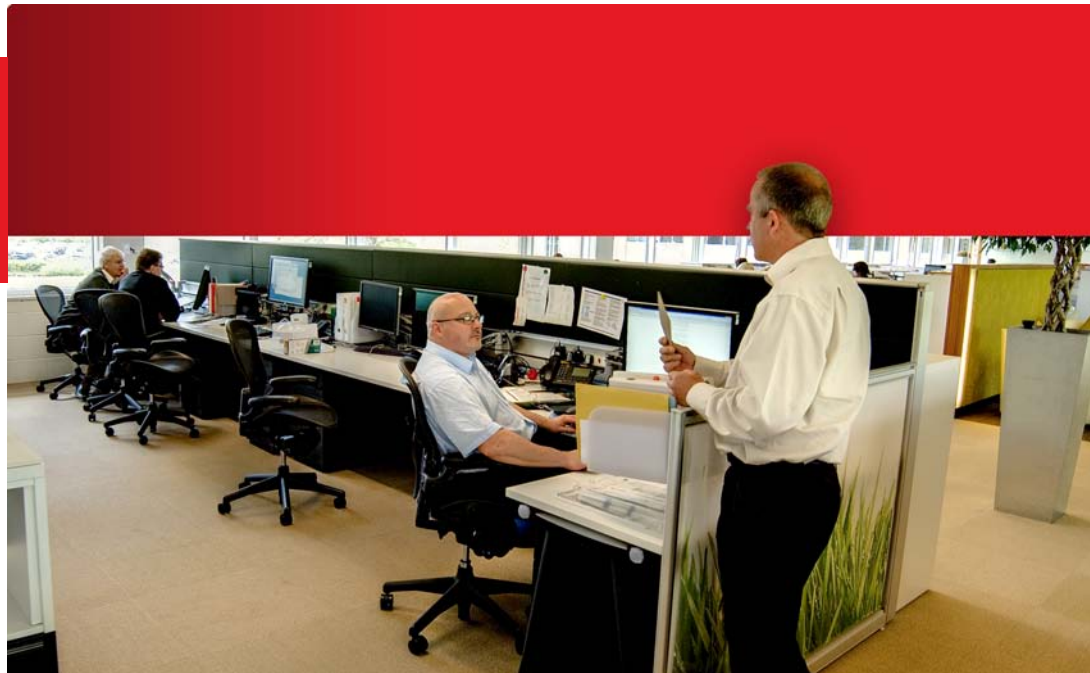

Reporting and analysis

With Infor PM Business Edition FR, you can provide production-quality financial income statements, balance

sheets, and cash-flow statements. You can also take advantage of comprehensive reporting and dashboard capabilities such as graphs, charts, tables, gauges, alerts, ad hoc navigation, user-driven color coding, and exception monitoring. All reports are instantly web-enabled and deployable using standard web browsers via a corporate intranet or the web. Preparing and distributing presentation-quality reports is easy using customized fonts, colors, and other formatting options. The solution allows you to view reports onscreen and easily drill down from financial summary information into account and transaction details. Business Edition FR allows you to view completed reports, send reports via email, and drill down from summary to detailed information.

In addition, Business Edition FR lets you perform departmental and multi-company consolidations (hierarchical roll-ups) while giving you the option to upgrade to Infor PM Financial Consolidation for a comprehensive set of statutory consolidation capabilities. Many end-user-driven features in Business Edition FR let users easily create and share information-rich financial reports. These end-user-driven features include ad hoc calculations, color coding and exception reporting, pivot table functions, private and shared views, ad hoc charting and graphing, status overviews of hierarchical information, user-driven rounding options, and the zoom-in/zoom-out feature, which allows very large sets of information to be displayed.

Analysis is easy with Business Edition FR, which allows tracking and reporting of financial performance at any point in time. You can track 12-month trends, actual versus budget variance, and year-over-year comparisons for income statements, balance sheets, and any defined dimension. Business Edition FR also allows you to see the financial effect of organizational restructuring without creating an impact on



general ledger data. You can compare revenue and expense figures for different departments by creating side-by-side reports, and load information into wildcard and defined ranges so new general ledger account additions automatically flow into the reports. In addition, you can package reusable account structures—called schedules—and reuse them without creating a new report. Plus, Business Edition FR gives you the ability to represent a hierarchical relationship between organizational cost centers with reporting trees. Not only that, you can export reports to Microsoft® Office Excel® or Excel PivotTable® for additional “what if” analysis, keeping formulas and underlying detail intact.

Audit trail


Infor PM Business Edition FR provides a full audit trail back to the information source, including account mappings. You can store statement-level annotations and footnotes in reports and retrieve them later for other reports that require the same information. You can also produce data activity reports, which log all data changes by user ID, date and time stamp, and many other attributes. In addition, you can produce process activity reports, which log all processing by user ID, date and time stamp, process scope, and other attributes.

Currency translation

Infor PM Business Edition FR allows you to report on any currency posted in your general ledger. The solution supports multiple currency exchange rates; you can load exchange rate tables from a service or from information in a general ledger. Business Edition FR maintains rates at the frequency required for reporting. Rates can reflect daily, spot, historic, or triangulation currencies; reports can reflect local currency, base currency, or any third currency. With Business Edition FR, you can calculate gains and losses based on currency exchanges.

Security

Infor PM Business Edition FR recognizes your need to control access to key financial information. As a result, you can apply security at both the user level and group level. You can even apply security by tree unit. In addition, you can base security on Lightweight Directory Access Protocol (LDAP) and use network user accounts for authentication.
