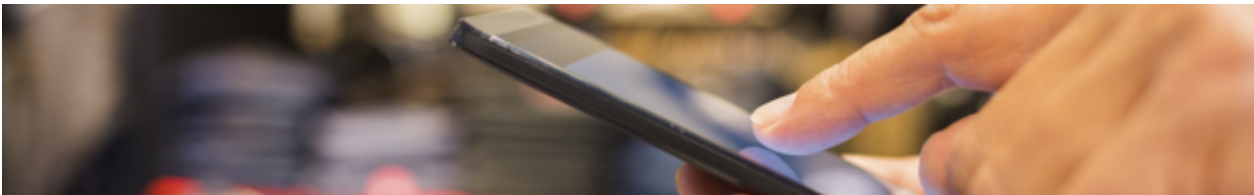
Automate and connect business processes using industry-standard methods

IPA includes a Designer component that gives your developers and business analysts a graphical, drag-and-drop-based design tool that allows them to automate simple and complex business processes. They can do this by combining application data from disparate sources, and configuring and managing business processes. As a result, you can accomplish a variety of tasks, such as:

- Assign, branch, return, and trigger control features (e.g., If-Then-Else conditions, return data to the initiated business process, define sub-process in parent process, and initiate another process from a current process).
- Automatically send workflow information that requires action to a user's in-basket.
- Include user action functions within the Infor Global Human Resources and Infor Talent Management reporting structure.
- Execute automatic functions with any web-based program.
- Call a web service and use any returned information as part of the process.
- Use notifications to send emails and SMS messages within a process to multiple phone numbers, tasks, and actors.
- Send messages to specified users in Infor Ming.le™.
